Good morning and welcome back to the lecture series on Partition of India in Print Media and Cinema. Today we are going to just walk through or take a tour of the kinds of work... kinds of works happening across the world in the diaspora on the topic of the partition of India. So, we need to familiarize ourselves, become you know aware of the kinds of scholarship being produced by notable scholars, academicians in the field of partition.

This survey lecture helps us to identify the important works that are being produced... that have been produced on the topic. And it is very important when someone is researching in the field to look up these scholars, primarily when we are looking at the course from the perspectives of... from historical, sociological, then feminist, and the filmic perspectives, right. So, for example, we have Dipesh Chakraborty in the diaspora; he is the faculty director at the University of Chicago Centre in Delhi, (Refer Slide Time: 01:57)

- Dipesh Chakraborty, renowned Indian historian is currently the Lawrence A.
 Kimpton Distinguished Service Professor in History, South Asian Languages and Civilizations, and the College.
- He is the Faculty Director at the University of Chicago Center in Delhi, a faculty fellow of the Chicago Center for Contemporary Theory, and an associate of the Department of English.
- His major works include Rethinking Working Class History(1989), Provincializing Europe(2001), Habitations of Modernity(2002), The Calling of History(2015), The Crises of Civilization(2018), Some Aspects of Labor History of Bengal in the Nineteenth Century: Two Views (with Ranajit Dasgupta 2019) and The Climate of History in a Planetary Age (2021).




a Faculty fellow of the Chicago Centre for Contemporary Theory, and an associate of the Department of English and he is a renowned Indian historian - currently the Lawrence A. Kimpton Distinguished Service Professor in History, South Asian Languages and Civilizations and the College. And some of Chakraborty's major works include Rethinking Working-class History, Provincializing Europe, Habitations of modernity, the Calling of History, the Crises of Civilization, among others. - Sekhar Bandhopadhyay, Emeritus Professor of History and Wellington, is the founding Director of the New Zealand India Research Institute.
- His major works include From Plassey to Partition and After: A History of Modern India (Second edition,2015), Caste, Protest and Identity in Colonial India: The Namasudras of Bengal, 1872-1947 (Second edition, 2011), Decolonization in South Asia: Meanings of Freedom in Post-independence West Bengal (2012), Caste, Culture and Hegemony: Social Dominance in Colonial Bengal (2004).
- He has recently co-edited Indians and the Antipodes: Networks, Boundaries and Circulation (2018), Religion and Modernity in India (2016), Calcutta: The Stormy Decades (2018).



So, then we have Sekhar Bandyopadhyay who is Emeritus Professor of History in the University of [Wellington]; he is the Emeritus Professor of History and the founding Director of the New Zealand India Research Institute. Some of his major works include From Plassey To Partition and After, Caste Protest and Identity in Colonial India, The Namasudras of Bengal between 1972-1947, Decolonization in South Asia: Meanings of Freedom in Post-independence West Bengal, Caste Culture and Hegemony, Social Dominance in Colonial Bengal. Then we have Joya Chatterji, a fellow of Trinity College, who is a Professor of South Asian History and a fellow of Trinity College, Cambridge. Some of the important works include The Bengal Diaspora, Rethinking Muslim Migration, Routledge Handbook of the South Asian Diaspora, The Spoils of Partition Bengal, and India 1947-1967, Bengal Divided: Hindu Communalism and Partition 1932-1947, among others. - Prabhjot Parmar is a distinguished scholar and professor at the University of Fraser Valley.
- Co-edited When Your Voice Tastes Like Home: Immigrant Women Writer.
 Published articles on the topics of Partition, Bollywood, history of Punjabi Cinema, among others. In her article "'Moving Forward Through Still Facing Back': Partition and the South Asian Diaspora in Canada" in the book Partitioned Lives she delineates how several works of fiction and film serve diaspora.
- Parmar introduced cinema studies as an increasingly popular field of study, where films can act as markers of class, caste, religion and gender.




Prabhjot Parmar is a distinguished scholar and professor at the University of Fraser Valley. And some of the works by her include When Your Voice Tastes Like Home: Immigrant Women Writer; and she also has published a very important article called "Moving Forward Though Still looking[Facing] Back: Partition and the South Asian Diaspora in Canada." And the former introduced Cinema Studies as an increasingly popular field of study while working in Fraser Valley, and she is looking at films that can act as markers of caste, class, religion, and gender. - Nandi Bhatia is a Professor at the University of Western Ontario. Her research
 explores the connections between literary and theatrical practices, nationalism,
 and colonialism, and examines the ruptures and crossovers that resulted from

 on a SSHRC funded project on the inter-linkages between colonial laws,
 nationalist practices, and the alternative public sphere of female performance in
 India.
- Her prominent works include Acts of Authority/Acts of Resistance: Theatre and Politics in Colonial and Postcolonial India (2004), Performing Women/ Performing Womanhood: Theatre, Politics and Dissent in North India (2010), edited collections Modern Indian Theatre (2011) and Partitioned Lives: Narratives of Home, Displacement and Relocation (2009), to name a few.



Nandi Bhatia is a Professor at the University of Western Ontario. Her research explores the connections between literary and theoretical practices, nationalism, and colonialism. She examines the ruptures and crossovers that resulted from the British Empire's long-standing engagement with India.

Currently, she is working on an SSHRC funded project, and her prominent works include Acts of Authority/Acts of Resistance: Theatre and Politics in Colonial and Postcolonial India, Performing Women/Performing Womanhood: Theatre, Politics and Descent in North India; and Partitioned Lives, Narratives of Home, Displacement and Relocation, to name a few. 


- Himani Bannerji works in the areas of Marxist, feminist and anti-racist theory. She

Sukeshi Kamra is a Professor at Carleton University and her research and teaching interests include contemporary Anglophone Indian Literature and Indian Literature in Translation, Postcolonial Theory, Law and Literature of British India, among others. Some of her important works are Bearing Witness: Partition, Independence, End of the Raj; The Indian Periodical Press and the Production of Nationalist Rhetoric; Kipling's Vision. And her monograph Bearing Witness reflects on the multiple meanings with which the end of colonial rule was imbued by the nationalists the partition refugees, and the British exiles. 


